3 (a) The objects to be pursued by the company on its incorporation are:

To promote education by establishing, supporting, and running schools, training centers, digital learning programs, after-school support, and other educational initiatives for children, youth, and underprivileged communities.

To undertake healthcare initiatives by establishing, supporting, and running hospitals, clinics, mobile health units, awareness programs, preventive health campaigns, blood donation drives, and providing medical assistance to the needy and underprivileged.

To protect and conserve the environment by promoting tree plantation, pollution control, sustainable development, waste management, renewable energy, and awareness programs on environmental sustainability.

To organize and promote cultural events by conducting programs, workshops, and festivals that encourage art, music, sports, and cultural heritage preservation for the benefit of the public.

To establish and maintain

orphanages for the care, education, shelter, and overall development of orphans and destitute children.

To establish and run old age homes and provide shelter, medical care, and emotional support to senior citizens.

To promote child welfare by supporting nutrition, education, healthcare, protection from abuse, and overall development of children in need.

To promote women welfare by encouraging skill development, financial independence, health awareness, legal literacy, and entrepreneurship initiatives.

To provide food and basic necessities to poor, homeless, and underprivileged sections of society through community kitchens, distribution drives, and social support programs.

To conduct regional surveys and livelihood programs to understand local communities, create employment opportunities, and provide home-based work for women engaged in traditional or domestic activities.

To uplift backward and marginalized communities by implementing welfare programs, skill development, social empowerment initiatives, and by providing access to resources that improve their livelihood and social status.

To organize and support mass marriages for poor and underprivileged families, with the purpose of reducing burden, promoting social harmony, and supporting the welfare of economically weaker sections of society.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To organize seminars, workshops, training programs,

and awareness campaigns in furtherance of the main objectives of the company, especially in underserved and marginalized communities.

2. To collaborate with governmental, semi-governmental, non-governmental, academic, and other institutions or organizations for knowledge exchange, capacity building, and implementation of socially impactful initiatives.

3. To publish newsletters, journals, research papers, books, reports, audio-visual content, and digital publications aimed at spreading awareness, education, and information consistent with the company's objectives.

4. To conduct surveys, field studies, impact assessments, and evaluation exercises to document progress and identify areas for improvement related to the company's activities.

5. To recruit, appoint, or engage professionals, trainers, consultants, staff, interns, and volunteers necessary to carry out the programs and operations of the company.

6. To support and organize public events, including exhibitions, fairs, conferences, and campaigns, that promote public interest, education, and awareness consistent with the objects of the company.

7. To establish and operate educational, wellness, or resource centers, including community hubs, learning spaces, libraries, helplines, or information kiosks that align with the public welfare objectives of the company.

8. To develop and distribute educational and awareness materials, including guides,

posters, manuals, toolkits, and digital content to enhance knowledge and positive behavioral practices.

9. To build cooperative relationships among stakeholders, including civil society organizations, academic institutions, community groups, and public bodies to promote shared learning and community development.

10. To conduct leadership and capacity building programs aimed at empowering youth, women, educators, and community workers in alignment with the company's social mission.

11. To promote education and awareness through creative expression, including street plays, art, music, storytelling, documentaries, and media campaigns related to the objectives of the company.

12. To coordinate with local and regional authorities and public institutions for effective implementation of socially relevant programs and to comply with applicable statutory requirements.

13. To document and disseminate best practices, impact stories, and learnings that can contribute to social awareness and improvement in areas related to the company's objectives.

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by its members or others, any regulation or restriction which, as an object of the company, would make it a trade union.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

6 No alteration shall be made to this memorandum of association or to the articles of association of the company which are for the time being in force, unless the alteration has been previously submitted to and approved by the Registrar.

7 The liability of the members is limited.

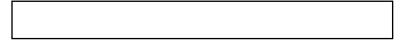
